

## *Interim Summary (Mediterra 2018)*

### ***Inclusion and Migration Challenge around the Mediterranean***

Migration and its impacts on territories of origin and destination has become a major concern in national and international political agendas. The growing vulnerability of rural livelihoods is a major trigger for ongoing migratory flows, with rural populations moving towards areas with higher economic potential. **Most rural areas in the region and beyond are characterised by outmigration.** This affects the local economy, society and agroecology. The implications of this phenomenon are significant in terms of food production, natural resource management, territorial integration, social protection and inclusive development – with impacts on the overall resilience and sustainability of our society. In the Mediterranean, this is particularly intense due to a multiplicity of interrelated factors. At the same time, **migration is increasingly recognised as a significant factor for the achievement of all three pillars of sustainable development – economic, social and environmental (IOM).** It is essential for the international community to better comprehend and support the development potential of migration for both migrants and societies.

In this context, the International Center for Advanced Mediterranean Agronomic Studies (CIHEAM) and l'Agence Française de Développement (AFD) are publishing the Mediterra 2018 report, which is aimed at improving knowledge on rural migrations in the Mediterranean from the perspective of rural and agricultural development in order to identify sustainable, inclusive and long-term solutions.

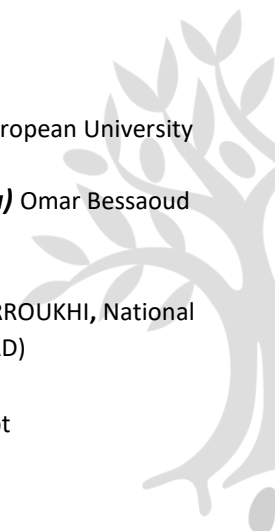
