solicitation and changes in the agri-food production / processing patterns, as well as in the food

consumption patterns and lifestyles in the Mediterranean region.

To ensure that the agri-food system be capable to respond to the new needs with the widest

possible benefits, it is necessary that the operators of the sector introduce new forms of

technological, organizational and social innovation and collaboration in their production,

transformation and distribution activities.

The reference to a paradigm shift in the production system emerges from the recent proposal of

the EU Green Deal addressing to mobilize research and innovation to foster a just and sustainable

societal transition aiming at new forms of agri-food entrepreneurship and value chain, 'leaving

nobody behind'.

The aim of the special issue is to develop knowledge and common innovative solutions for Agri-food

systems in the Mediterranean area, to make them sustainable, and by an integrated management

more climate resilient, efficient, cost-effective and environmentally and socially sustainable, and to

contribute to solving food security and health problems.

The final objectives of this Special Issue are to provide a wide analysis of the status, potential,

challenges, and recent developments of sustainable farm and food business model innovation in

Mediterranean area and to open a discussion for new ideas to improving health and livelihoods
